The Biodiversity Heritage Library (BHL) is a consortium of major natural history museum libraries, botanical libraries, and research institutions that cooperate to digitize and make accessible the legacy biodiversity literature. Together, the consortium accounts for over two million volumes of biodiversity literature collected over 200 years. Open access to the resources in the Biodiversity Heritage Library supports the work of scientists, researchers, and students in their home institutions and throughout the world.

The following title(s), protected by your copyright, has(ve) been identified as important to the mission of the BHL and has(ve) been requested by several researchers for digitization.

You may choose to add an embargo period of any number of years and BHL will digitize through a particular year, with subsequent years digitized on a rolling basis (e.g. a 5 year embargo allows for digitization through and including 2010 in 2015, 2011 in 2016, and so on).

Titles are digitized for BHL from the holdings of participating institutions in the consortium at no cost to you and you are welcome to re-use the content as you see fit. BHL, in no way, seeks to obtain ownership of copyright for the content specified in the enclosed agreement. Over 150 publishers have agreed to let us digitize and provide their content for free and open access on our website (<http://www.biodiversitylibrary.org>).

If you are willing to grant permission for BHL to digitize the title(s) listed above for the purpose of making this(ese) publication(s) available to researchers then, please take the time to review, sign, and return the attached form via email or via post to 10th St & Constitution Ave NW, PO Box 37012 MRC 154, Washington, DC 20013-7012. I will then have the BHL Program Director, Martin Kalfatovic, sign the form and return it to you.
